### **CHILD DESK**

#### Introduction

Over recent years the reported levels of child abuse and violence in Vanuatu have increased to alarming levels. This highlights more than ever the need for effective coordination and collaboration of all child protection actors and the strengthening of our Child Protection systems.

The Child Desk plays a vital role in collaborating with Child Protection actors to build partnerships to strengthen Vanuatu responses to protecting our children from abuse and all forms of violence.

There is lots of good news to share about the work of the Child Desk for example did you know that:

The National Child Protection Working Group(NCPWG)has been reconvened with a number of new members nominated by the Heads of Agencies. The NCPWG's purpose is to act as a national level coordinating body to work towards ensuring that all children in Vanuatu are protected from violence, abuse, exploitation and neglect at all times including during

# **REGIONAL COOPERATION IN CORRECTIONS**

The Department of Correctional Services has again shown its commitment to professional development of senior staff, following the return of two officers from Papua New Guinea.

Acting Principal Correctional Officer John Jack George and Senior Corrections officer Daniel Nakou spent 14 months in Papua New Guinea to undertake training with the Papua New Guinea Correctional Service Academy and the University of Papua New Guinea.

"Their achievement in being awarded a Diploma in Corrections Administration is the first of its kind for Vanuatu", said Director of the Department of Correctional Services, Mr Johnny Marango. "It is a high academic level of learning. The training targets middle managers and officers in higher ranks, such as Managers, and Prison Superintendents. The training covers subjects including Corrections Administration, Operations, Intelligence, National Security, Joint Forces Frameworks, Communications, Strategic Planning and Finance".

"This training will not only benefit us, but the whole Department of Correctional Services in Vanuatu", said trainee John Jack George. "We are back to serve the Government and the People of Vanuatu to rehabilitate commitment to protecting children from harm, abuse and exploitation. And to clearly articulate the Ministry's approach to protecting children from harm in the course of our work.

□Louise Nasak Sector Capacity Development Coordinator and Child Desk officer James Agna joined the DG Henry Vira- Ministry of Youth and Sport in Fiji recently for the Pacific Regional workshop on Child Protection for the Social Welfare Sector conference.

Child Protection training was conducted in partnership with UNICEF and the Ministry of Youth and Sport to Area Secretaries and Local Councillors in Shefa and Sanma provinces.

#### **REGIONAL RIGHT RESOURCE TEAM**

#### Universal Periodic Review (UPR) Mock Session 17 – 18 January 2019

The two-day mock session was facilitated by the Pacific Community's (SPC) Regional Rights Resource Team (RRRT) on 17-18 January in collaboration with the Melanesian Spearhead Group (MSG). The session was held as part of the UK-funded Pacific Commonwealth Equality Project. The session was attended by the Minister for Justice, Honourable Don Ken, who will lead a ministerial delegation to Geneva for the UPR process.

Nineteen participants from the Vanuatu government and Civil Society Organisations (CSOs) took part in a mock Universal Periodic Review (UPR) session in Port Vila. The Vanuatu government will be undergoing their third UPR at the United Nations Human Rights Council in Geneva on 24 January 2019, where the nation's performance in protecting and promoting human rights, and the progress made in implementing recommendations from its previous review will be assessed. Director General of the Ministry of Justice and Community Services, and Head of National Human Rights Committee, Ms Dorosday Kenneth echoed this sentiment after the conclusion of the session, "the mock session provided the delegation with the opportunity to understand the scope of what is expected in Geneva and it has also allowed them the chance to understand what UPR is as an international forum to openly discuss the issues of human rights in the country," adding, "The high attendance by representatives of the different government sectors at this mock session indicates the Vanuatu government's commitment to implementing human rights recommendations across all divisions."

The session in Vanuatu is part of RRRT's wider ongoing work in Pacific to support countries engagement in the UPR processes. Mr Miles Young, Director of RRRT, highlighted the importance of these sessions for the region saying,

"mock sessions are a vital part of preparation for State delegations as it gives them a chance to rehearse their answers and receive critical feedback on their presentation and responses. The session which has concluded in Vanuatu will help ensure the dialogue in Geneva is richer, leading to more relevant recommendations and increased impact on the ground."

refresher workshop on the Convention on the Rights of Persons with Disabilities (CRPD) with a mock session for the government delegation preparing to travel to Geneva to report on Vanuatu's implementation progress of the CRPD.

"The CRPD provides the legal framework to which State Parties are assessed on their commitments to upholding, promoting, defending and protecting the rights of persons with disabilities. It is one of the core human rights treaties and was open for signature and ratification in 2007. Like other core human rights treaties, State Parties must submit a periodic report a year or two after ratification and a periodic report between two to four years thereafter," said Romulo Nayacalevu, the Program Manager for Governance and Legal Affairs at the MSG, who facilitated the two-day event.

In this CRPD mock, the government delegation was asked questions regarding the implementation of various Articles in CRPD including issues of accessibility. the nondiscrimination, and reasonable accommodation. The delegation responded to these questions and provided updates on what the Government has done since ratifying the CRPD. Some of these positive acts include undertaking a comprehensive CRPD legislative compliance review in 2016, the moves to amend discriminatory laws against persons with disabilities, the formulation of national policies and frameworks including inclusive education and access to health care and various other initiatives relating to employment for persons with disabilities, their habilitation and rehabilitation, access to assistive devices and their participation in political and public life as well as cultural, recreation, leisure and sports among others.

#### Family Protection Act Training for State Prosecutors -13 – 15 March 2019

Vanuatu Police Prosecutors and other law enforcement officers participated in a three-day training (13 to 15 March), aimed at strengthening their role in the implementation of the country's Family Protection Act.

The training was organised by the Ministry of Justice and Community Services, through its Stretem Rod Blong Jastis mo Sefti Programme, and the Pacific Community's (SPC) Regional Rights Resource Team (RRRT), with funding support from the Australian Government.

Statistics show that around 60 % of women in Vanuatu have at one point in their lives experienced domestic violence.

Women who experience domestic violence are prevented from engaging and participating fully in their families and communities. Enacted in 2008, the FPA defines and criminalises domestic violence namely physical, sexual and psychological abuse between family members. The FPA further provides for Family Protection Orders.

The Director General of the Ministry of Justice and Community Services, Dorosday Kenneth opened the training with the presence of SPC's Regional Director for Melanesia, Mia Rimon. In her opening remarks, the Director General called on Police Prosecutors to believe in the cause legislated under the Family Protection Act.

Inspector Smith Obed, a participant at the training said the Act was there for years but not fully implemented due to lack of knowledge on the role of Police Prosecutors under the Act. "With this training, we learnt so many new things and it strengthened and equipped us in what to do. For instance, to have a common understanding of the "No Drop Policy", not to be influenced by custom reconciliation and to have a system or mechanism in place to prioritise domestic violence cases," he said.

The training is part of SPC RRRT's regional judicial strengthening programme, which provides tailor-made training programmes to support judges, magistrates, lawyers and prosecutors in implementing family violence legislation. In 2017, RRRT worked with the Chief Justice of Vanuatu to support the Vanuatu Magistrates to get a better understanding of the Family Protection Act.

# Women of the policing, justice and community sector: Inspiring leaders of the future

The Vanuatu Justice, Policing and Community Services sector continue to demonstrate their commitment to gender equality through connecting women's voices to leadership. With the support of Heads of Agencies across the sector, female sector officers are coming together regularly for short, inspirational 'Storian tugeta. Leftemap vois.' lunch-time sessions. Some officers are also part of a 12-month formal mentor-mentee program. These initiatives, part of the Women in Leadership Mentoring Program (WiLMP) are coordinated by a cross-sectoral Oversight Group with the support of the Australian Government-funded Vanuatu Australia Policing and Justice Program.

The first lunch-time session for 2019 was held on 28 March and attended by 73 officers from across the sector. Three current female leaders in Government and Tertiary Education - Mrs Dorosday Kenneth Watson, Director General, Ministry of Justice and Community Services, Lieutenant Dora Sahe, Vanuatu Mobile Force and Ms Ketty Napwatt, Facilitator in Language-Preliminary & Foundation Language courses for Pacific TAFE, University of the South Pacific – shared the highlights and challenges of their careers to date and offered advice to women in pursuit of their professional and personal dreams. Participants felt the session was 'empowering and encouraging', full of 'interesting, powerful stories from [the] panellists'. Each set their own goals following the session, including to work more closely with their colleagues to achieve organisational goals, to actively share their knowledge and skills, to look for and take up development opportunities and to acknowledge and celebrate the achievements of women in all aspects of their lives. Progress against these goals will be tracked across future 2019.

#### VANUATU LAW REFORM COMMISION

# VLRC undertakes School Awareness and Provincial Consultations.

Most people in Government Departments and Ministries in Vila seemed to have never heard of the Vanuatu Law Reform Commission. If that is the case in Port Vila, then what do we expect of people in the provinces? This is evident when the Vanuatu Law Reform Commission engaged with Schools within the vicinity of provincial headquarters and provincial Councils at the end of April and beginning of May 2019.

The Consultation with provincial councils was on proposed changes to the Law Commission Act.

As to the schools, the visits was to undertake the following: (a) Provide awareness on the role of the Vanuatu Law Reform Commission;

(b) Engage senior students on a Logo competition (assist in the review of the current logo); and

(c) To provide motivation to students to study harder for a bright future

In the first session, students were informed of the Mission and Vision Statement of the Vanuatu law Reform Commission, when was the office established and what is the role of the Vanuatu Law reform Commission. It is the primary purpose of the awareness is to inform the students on the role of the Vanuatu Law Reform Commission and to provide an opportunity for these students to ask questions about the institution as well as the sessions were used as a Career talk to inform students about law reform and areas of study leading to careers in law reform.

The other reason behind the awareness is to engage Senior Students on a competition to design a new logo for the Vanuatu Law Reform Commission. The dateline of this logo competition is the 31st of July 2019. If one looks at the current logo of the Vanuatu Law reform Commission, it does not reflect any aspects of law reform.

In terms of the motivational sessions, topics that were covered include Struggling and growth, being optimistic, no need to be a genius but do your best in all subjects and stop procrastinating.

It is believed that these awareness sessions have increased the public relations of the VLRC and students throughout all sic provinces know about the Law Reform Commission. After the schools, consultations were also undertaken with the six provincial councils within the first week of May 2019 on proposed changes to the Law Commission Act.
